That reaching out, being of service, makes you a valuable team member to support your community in times of need. The contacts you make today can have a big impact tomorrow!



From your Treasurer—Andy Templeton, City of Sand Springs

As your OCEA treasurer, I'm pleased to report we are sustaining ourselves as an organization very well. As of mid-September, we had more than \$80,900 in our bank account. Bear in mind our funds are fluid as events such as classes, conferences, outreach programs and administrative expenses occur.

Within that account balance, the OCEA Board has voted to encumber funds for the 2022 Community Improvement Grant program. As I'm sure others will share with you, it is bigger and better than ever. Of most importance, it is pre-funded so we can remain true to our commitments.

Our work in code enforcement remains exceptionally difficult amid the pandemic, the lifting of eviction moratoriums, divisive attitudes by citizens of all stripes, and most significantly, mental illness. I've had a couple of encounters with the latter recently that bear sharing.

The first was a mentally ill gentleman who reportedly had violent tendencies. He came to our attention after a minor electrical fire in his home. The situation worsened as he allowed grass to grow and trash to accumulate in his yard. He also spray-painted a lengthy and uncomfortable message to his neighbors on his garage door. I had to serve an abatement notice on the property and also had to assure the electricity was still turned off. Fortunately, the abatement notice spurred the man's family to get involved in the process. He is receiving the treatment he needs, and they oversaw a major cleanup without us getting directly involved.

The other involved a lady who had high grass in the yard of her residence. Despite repeated assurances that it was going to be mowed, it never happened. Our contractor was mobilized with a City employee monitoring the situations. Things got out of hand rather quickly, and we had to summon a notable police presence. I must commend our police officers for displaying eternal patience in searching for a solution that allowed her to stay in her home while we finished our work.

When you come to work each morning, remind yourself of how important it is to pay attention to everything going on around you. Don't hesitate to reach out for additional resources to protect yourself and others. It's all about going home at the end of the day.


