Hello Members and Colleagues,

I am praying you are managing well and are in good health. I was personally hoping all the grass would burn up here, but we were blessed with a bout of rain in August. With the rain and slightly cooler weather, the grass and weeds have begun growing again. Ohh well, it looks like we will be mowing until Halloween.

On another note, we have had many members over the years ask about the legislative process and what that entails. OCEA has been involved in multiple attempts at passing legislation; engaging in many parts of the legislative process. I have included a basic breakdown of the process and Oklahoma's basic timeline.







Committee consideration

The bill is sent to a committee for study and recommendations. The committee may vote to send the bill to the full chamber for consideration, or it may vote to not pass the bill.

Chamber consideration

The bill is brought to the floor for a vote. If the bill passes, it moves to the other chamber.

Conference committee

The other chamber may amend the bill, and then the two chambers may send it to a conference committee for further amendments.

Governor's consideration

The bill is sent to the Governor for consideration. The Governor can sign the bill, veto it, or wait five days for it to go into effect.

Veto override

If the Governor vetoes the bill, the Legislature can override the veto with a two-thirds vote.

The Oklahoma Legislature is made up of two houses: The Oklahoma Senate and the Oklahoma House of Representatives. The regular session of the Oklahoma Legislature takes place from February through May. Usually by October we are working with Representatives and Senators on Bills to get drafted for the upcoming session. The drafting of Bills and Joint resolutions deadline is usually in December. This is a short version of the process, but I hope it gives some a better understanding. I hope you all have a wonderful Autumn season and I look forward to seeing you all in Chickasha in October.
